- (1) The applicant school has produced its proposal before the fee Regulation committee, Vadodara Under the Gujarat Self finance School (Fee Regulation) Act-2017 and under the Gujarat Self-finance school Fee Regulation (rules) 2017 Rule-6, According to that proposal states to decided to the fee for the year 2021-22 to 2023-24 for 3 years In which the applicants school has proposed to raise the fees as follow:

- (2) The applicant school had filed proposal no. 03/2020-21 to decide the fees for the year 2021-22 to 2023-24 In view of that an interim order was made on 18-04-2022 by the F.R.C. As per mentioned in the order if the school is dissatisfied of the order, the school has to put a review application with causes to the F.R.C. Vadodara within 7 days. In case the applicant school may fail to forwards review application in time it was decided that the interim order shall be considered last and final.
- (3) The applicant school had made review application on 25-04-2022 against the interim order. Which was filed by rev. application no. 94/2021-22 order stating in the application.
- (4) Against the Review application of the applicant the Fee Regulatory Committee heard to the applicant school and made the final order on 26/05/2022 with the following terms and conditions as follow.

- (5) The applicant school had filed Revision application before the F.R.C. Committee Gandhinagar no-66/2022-23 against the order of F.R.C. dated-20-04-2022. The applicant school was heard against the revision application on 06/07/2022 wherein the rev. application was sanctioned and the applicant school had been given enough opportunity ordered to make a fresh order.
- (6) After the order made in ref. of the revision application of the school, notice issued for hearing and intimated to presence in hearing on 26/07/2022. The authorized representative was appeared on behalf of the school. And he submitted in writing wherein stated that the Fee Reg. Committee has decided equal fees for all standards which should be made revised. No other representation has been made.
- (7) The applicant school had field proposal for the year 2020-21 to 2022-23. The said proposal for the year ordered on 05-03-2021. The said proposal no. 35/2020-21 ordered on 07-09-2021. Wherein fees fixed for the year 2019-20 by Guj. Gov. Edu. Dept. Sachivalaya, Gandhinagar resol. no-BMSh/1220/53/F.R.C.L dt. 07-10-2020 the self Finance school had to collect the fees in view of the fees circulars made under Covid-19 situation against the fees fixed for the year 2019-20 against that fees the school had to collect 75% fees for the year 2020-21 and ordered accordingly.
- 8) Due to raise the present situation of covid-19 pandemic it is ordered to close all schools of state (Govt. Grant in Aid, Self Finance) from 16/03/2020 Lockdown was declared by the central govt. time to time, at that time schools were closed and at present also as per directions of the central govt. it is ordered to start educational institutes. And inview of this situation the account audited for the school for the year 2019-20 and as per numbers of students of that year the interim fees for the 3 years 2021-22 to 2023-24 is to be decided to fix by the Fee Regulation Committee. Because, the school has decided to collect fees for the year 2020-21 on the 75% fees of the year 2019-20. The school does not run full time, less fees received from the students, and the school has spent less towards expenses. Therefore accordingly

to audit of the year 2019-20 decided to fix in view of the year 2019-20 fees is just & proper with a view not to loss the school trust and students guardian.

- 9) The applicant school has submitted audit account of the year 2019-20. Looking to that income expenditure account by the Fee Reg. Committee it is decided to determine fees considering the numbers of students for that year.

- 10) Inview of checking the income produced by the applicant school, the admission fee and term fee is fixed are included in Guj. Self-Finance Fees Regulation Act, year 2017 Sec-2 (g) wherein the admission fee and term fee and other fees are including only under a head of fee. The numbers of the Students are 650 for the year 2019-20. The school has collected average fees Rs. 44,425/- while Rs. 44,158/- was fixed by the F.R.C for the last year. Instead of that the applied school has received more income Rs. 267/- from each student. Thus the school has received more fees of Rs. 1, 73,550/- As per order of Hon. Supreme Court Special Leave Petition no. 314/2018 the school can be entitled to collect the extra fees of optional activities if the student has accepted the optional activity. And not entitled to collect fees by any other way excluding that.

- 11) As per order of fee Reg. Committee in Revision Application no-66/2022-23 dated 06-07-2022 the Fee Reg. Committee has not fixed fees for applicant school senior secondary ( Higher Secondary). Therefore order made to remand for fixation of fees. Interference has not been made, to applicant school for the fees fixed for Pre. Primary, Primary, and Secondary.

- 12) After order of the revision application of the school a notice was issued on 26/07/2022 to hear in person. Inview of the notice the representative of the applicant school was appeared. The representation of the applicant school has given consent in writing that, if fees may be fixed 52000/- for higher secondary he has no objection. When proposal was made in 2019-20 in the applicant school there was no standard in higher secondary. Therefore there was no student in the year 2020-21. The suggested fees was not asked for higher secondary when proposal was made. The fees for higher secondary is made after order of review application. Thus in view of representative made by the school

**CONDITIONS:-**

- 1) The fee fixed for the year 2021-22 is fixed fee under the Gujarat Self Finance (Fee Regulation) Act 2017 sec 2 (G)
- 2) The applicant school can collect extra fees for optional activities than the fee for the year 2021-22 and for that consent should be taken from the student and his/her guardian.
- 3) The applicant school can collect educational fees monthly and yearly for the year 2021-22. But the school cannot collect penalty more than interest rate of bank.
- 4) In case any parent has paid more fee for the year 2021-2022 against the interim order shall be adjusted against the fees of other quarter.
- 5) The 5 percent increased fees by the Fee Regulation Committee in the year 2021-22 can be carry forward for the year 2022-23 an 5 percent increased fees in the year 2022-23 can be carry forward for the year 2023-24.

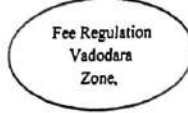

- 6) The applicant school cannot be collect more fees then the order of interim fees. In case there may alter in the interim order or alter in order of fee Rev. Committee in such case. The fees can be changed in the second quarter of the ordered date. Excluding that the school has to collect fees from the student as per order made by the Fee Regulation Committee. And if not followed the order the legal steps shall be taken against the school under the fee regul. Act.
- 7) The applicant School has to publish the fee fix by Fee Regulation Committee Vadodara for the year 2021-22 on school notice board and website of school in English and Gujarati.
