## Terms & Conditions:-

- The School shall abide by the provisions of right of children to free & Compulsory education act, 2009(Annexure 1) has to follow all rule & regulations.
- Permission is granted to management of school who fulfill terms & conditions under sub rule 2009 for academic year 2014-15.
- A) Managements who fulfill all requirements for opening new school or upgradetion as per Govt. Rule can apply within 1 month after starting academic year for first recognition by district Education officer.
- B) Management/Trust those who are eligible as per Ref.No-2 year 2014-15 but do not fulfill all conditions for upgredetion/establishment of school as per govt. rules. It is compulsory for them to start school within 18 months otherwise permission given will be automatically cancelled.
- C). Education Trust/ School those who are interested to affiliate with CBSC /ICSC, IB, IGSE, IE, education board and have been granted permission as per GR at 20 June 2012 are necessary to take first recognition for obtaining NOC. Such recognition will be given to school as per Para. 10 of GR by Dist. Education officer (Primary) Dist. Education Officer (Secondary) after getting it from DEO (Primary) management will apply to Govt.After scrutinizing and Verifying that trust/school is fulfilling all terms and conditions. It is compulsory for trust / school to obtain NOC of state govt. affiliation with above mentioned boards.
- 3) As per permitted new / Upgraded schools as mentioned in letter :-
