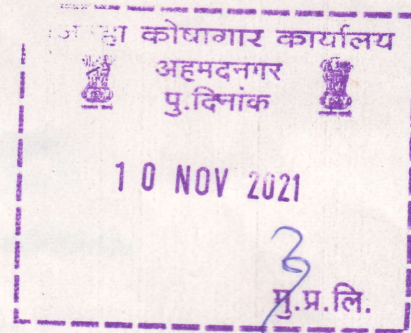




That the grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond class-VIII.

1. The school shall follow all the provisions under Right of Free and Compulsory Education to Children Act 2009 (Annexure 1) and Free and Compulsory Education to Children Rules 2011 (Annexure 2).

2. The school shall ensure that the school shall admit in class-I, to the extent 25% of the strength of that class; Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion provided that in case of pre primary classes also, this norm shall be followed.
3. That for the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.
4. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
5. The school shall not deny admission to any child for lack of age proof, religion, caste or race, place of birth or any of them.
6. (i) The school shall ensure that no child admitted shall be held back in any class or expelled from school till the completion of elementary education in the school.




