

Statutory Provisions Under Maharashtra Fire Prevention and Life Safety Measures Act, 2006

- 1. <u>Under Section 3 of "Maharashtra Fire Prevention and Life Safety Measures Act</u>, 2006" (here in after referred to as "said Act"). The applicant (developer,owner, occupier by whatever name called) shall comply with all the Fire and Life Safety measures adhering to National Building Code of India, 2005 and asamended from time to time failing which it shall be treated as a violation of thes aid Act.
- It is presumed that you have completed the work adhering to the provisions under Section-3 of the said Act.

- 3. Under sub-section (3) of Section 3, it is responsibility of the Owner or the Occupier as the case may be, shall furnish to The Chief Fire Officer or nominated officer a Certificate in aprescribed form twice a year in the Month of January & July regarding maintenance of fire prevention and life safety measure in good repair and efficient condition as specified in <u>sub-section (1)</u>.
- 4. <u>Under subsection (4) of Section 3</u>, no person shall tamper with, alter ,remove or cause any injury or damage to any fire prevention and life safety equipment installed in any such building or part there of or instigate any other person to do so.

<u>The condition mentioned in the "Provisional No-Objection Certificate" will remain un changed.</u> The undersigned reserves right to amend any additional recommendations deemed fit during the stage wise inspection due to the statutory provisions amended from time to time and in the interest of the protection of the company. If any change of Activity or Transfer of Plot or any future expansion, No-Objection Certificate from this office is essential
