Subject : According to section 18 of Free and Compulsory Child Education Right Act, 2009 and Rule no. 11, Sub Rule no. 4 of Free and Compulsory Child Education Right Act, 2011, to give recognition certificate to the school.

R/Sir,

As per your letter dated 27.11.2020 and reference, as well as correspondence/inspection of school

I Education Officer (Primary), Zillha Parishad, Nashik do hereby given temporary recognition to Potdar International School, Gangapur Road, Nashik, since 01.04.2019 to 31.03.2022 for standard 1th to 8th.

The recognition is subject to following terms and conditions –

- 1] Terms/period of recognition will not be extended. It is not binding to continue recognition after 8th standard.
- 2] The school must abide Free and Compulsory Child Education Right Act, 2009 (along with supplement) and Free and Compulsory Child Education Right Act, 2011 (along with supplement).
- 3] The school must give 25% admission to economical backward class and give them all primary education, Free and Compulsory Child Education of the total strength.
- 4] According to section 12(2) the school will get compensation, as mentioned in above column no. 3, for which the school has given bank account.
- 5] The society/school will not recover any capitation fee or does not force the child/student/parents to pay such fee at the time of

- 6] No student will deny admission on account of religion, cast or creed, place of birth or about their proof.
- 7] (ONE) No student will be stranded in the same class nor he will be rusticated from the school up to his completion of primary education.
- (TWO) No student will be harassed physically or mentally by punishing him.
- (THREE) No student will be made compulsory to pass the examination of the board.
- (FOUR) Every student will be given certificate according to Rule 23 after completion of his primary education.
- (FIVE) Handicapped/special attended student's need will be satisfied according to the Act and its provisions.
- (SIX) Minimum qualified teachers will be appointed according to section 23(1) but such teachers will have to earn the required qualification within 5 years from the date of appointment.
- (SEVEN) All teachers will do their duties according to section 24(1) of the Act.
- (EIGHT) The teachers should not involve himself/herself in any private tuition.
- 8] The school will follow the syllabus prescribed by the education department.
- 9] According to section 19 of the Act, the school will give admission to the students according to available amenities.

10] At the time of inspection following are the amenities found –

School surrounded area : 6320 sq. mtr.

Total construction : 1547 sq. mtr.

Playground area : 2528 sq. mtr.

No. of class rooms : 15

Office and store and room for Principal.

Separate bathroom for boys and girls. They should be cleaned and healthy, having sufficient water provided.

Drinking water facility

kitchen for preparation of lunch

Library/sport's material/and books for reading should be easy available.

11] No classes/standard/division could be run beyond the premises of the school, which has no recognition.

12] School building/construction and playground must be used for the education purpose/sport's skill only.

13] The school is run and manage under the registered school under Society Registration Act, 1860 (18/21) or Mumbai Public Trust Management Act, 1950.

14] The school is not run for the benefit/interest/profit, for any individual/group of person.

15] All the statement of account of the school must be audited from an authorized auditor and copy of audit report must sent to the Education Officer.

16] Index number of recognition of your school is RTE/NSK/NMC/PRY – 127. At the time of correspondence



Education Officer/government, must follow by the school and try to cure deficiency in the school working.

- 18] Renovation of the certificate of registration must be done time to time.
- 19] According to supplement no. 3, additional terms are attached herewith.
- 20] According to section 18 and 19 of Free and Compulsory Child Education Right Act, 2009 and government circular no. SSA/2013/M. No. 75/Pra. Shi. 4, dated 29.06.2013, it is the responsibility of Education Officer, (Primary) and Education Officer, (Secondary) to check final and physical amenities provided by the school as per criteria.
