
The School Administration of the Poddar International School, situated at # 289/2, Prestige Honda Show Room, Bangalore Road, Kanakapura Town, managed by the Poddar Charity Trust # 85, Poddar Centre, Dr. B R Ambedkar Road, Mumbai, had submitted an application directly to the Government to provide an NOC to frame a C B S C syllabus to its school.

As the Rules are framed regarding this under the Government letter No: ID 63 PGC 2013, dated 11/05/2022, and published in the State Gazette, the above matter was verified as per the said Rule, and it is informed to take further steps, and the proposal in ref (1) is returned back.

In ref (3), the Block Education Officer of the Government Education Department, Kanakapura Taluk, in regard to the said school on being provided with an NOC to frame a CBSC syllabus, an offline proposal is submitted, as it is not provided at present to submit an online proposal. In addition, it is submitted that the said school can be provided with an NOC for framing a C B S C syllabus.

In this regard, on 07/06/2022, the Block Officer visited the school, verified the documents, and submitted a report stating that the school shall be approved to frame a CBSC syllabus. Hence, in providing an NOC to the said school in relation to framing a C B S C syllabus a necessary proposal is attached along with this letter and submitted, and also it is opined as per the opinion of the B E O to provide an NOC to frame a CBSC syllabus, and hence, it is submitted for your further action.


