5. The state Government will not bear any financial or administrative responsibility of the proposed school. The state Government will not be responsible. If the school/ institution breached of any rules/norms or regulations laid down by above said board.
6. The institution shall have to obtain necessary permission of Government of India and other concerned authorities where it is necessary
7. The school shall appoint only qualified and eligible staff as per qualification laid down in R.T.E. Act-2009/ R.T.E. Rules.
8. The School and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board /State Education department at any time and the School shall furnish information as may by asked for by Board/ State Government

7. The School shall upload their data to U-DISE System (Unified District Information System for Education) and update it regularly.
