- Indian History especially "History related to Maharashtra" shall be taught in the school. Failing which this No Objection Certificate shall be withdrawn.
- The Complaint Redressal Committee regarding sexual harassment at school premises should be formed as per government resolution, woman and child department No.मकची-2013/ प्र.क्र.63/मकक Dated 19.6.2014 and subsequent provisions in Act and Rules.
- Fee Structure of the school shall be displayed on Government's RTE portal.
- School shall enter the Aadhar Number of the students on SARAL portal. 15.
