SI. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 3 (1 section each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to X shall be restricted to 14. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by law and availability of class rooms of greater than 500 sq ft dimension.
2	The school does not have RAMP/Lift to access upper floor for CwSN. Hence, the school is directed to construct Ramp to access upper floor/install Lift within 3 months and submit compliance on SARAS with videography.
3	The composite lab has a single work station, probably for chemistry section, while bio and physics equipment are placed on side slabs which are not conductive for conducting experiments. The lab should have a separate work station for Bio section and lab standard table for physics section. Storage should be separate room or covered racks with restricted access instead of cabinets under work stations which constrain movement of students and are unsafe. The school shall upgrade the lab as per sop issued by the board within 3months and submit compliance on SARAS with videography.
4	Math lab is a temporary arrangement and no proper workstations / seating arrangements. No storage is seen. Hence, the school is directed to upgrade the lab as per SoP issued by the Board and submit the compliance within 3 months on SARAS portal.
5	Playground needs to be properly maintained & developed. The seating arrangement in Indoor sports room is not proper. Sports items are inadequate. Hence, the school shall upgrade the indoor and outdoor sports facilities as per SoP issued by the Board within 3months and submit compliance on SARAS with videography.
6	As suggested by IC, more books needs to be procured for Library. Hence the school is directed to comply with the observations of IC and upgrade the library as per SoP issued by the Board and submit the compliance within 3 months on SARAS portal.
7	The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school is required to renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
